Submission of Bids: Bids shall be submitted in two separate envelopes named as, 'Technical Bid" (Format-1) and "Financial Bid" (Format-II), Both the Sealed envelopes of "Technical Bid" and "Financial Bid" Should be kept in the third envelope and the sealed envelope superscribed as "Tender for disposal of obsolete computer hardware and other office automation machine". The envelopes should be clearly marked as "Technical bid' (Envelop-1) and "Financial Bid" (Envelope-II). The bidder shall submit an EMD alongwith Technical Bid in the form of Demand draft amounting to Rs. 5,000/- (Five thousand only) drawn in favour Principal Govt. College Hamirpur, failing which the tender will be summarily rejected. EMD in any form other than stated above shall not be accepted.

(a) Technical bid shall contain the information in Format-1 duly supported with the document (Duly Self attested). The rates of the items shall not be quoted in technical bid.

- (b) The financial bid in format-II, of the tenderers whose bid is found technically qualified will be opened in the presence of the tenderers, who choose to attend the opening of financial bid.
- (c) Tenders received in the single-bid system or having the technical as well as financial bid in the same envelop shall be rejected.

GENERAL TERMS & CONDITIONS OF TENDER:-

- 1. Bidders may inspect the items on the stipulated date and time.
- 2. The items shall be sold to the highest bidder.
- 3. List of items is given in Annexure-'A'.
- 4. The Earnest Money Deposit (EMD) of successful bidder shall be returned after full payment of the bid.
- The successful bidder has to make full payment within 05 days, failing which the offer will be cancelled and EMD shall stand forfeited. The EMD of unsuccessful bidders shall be returned without any interest.
